4. What the full staff compliment should be on a whole

There is no staff 'complement', this does not exist.

5. How many whistle blowers have come forward including the subject matter and outcomes including the fate of each person making the claims.

During the past 5 years:

- 2 groups of staff in two areas all still employed between them there were probably around 15 staff
- 1 individual still employed
- 1 no longer here as post made redundant
- 1 bank worker not employed and no longer here

The Trust has also received approx. 5 anonymous whistleblowing allegations. These were all investigated but proved unsubstantiated. The position of those people is not known as they were anonymous.

For whistleblowing the Trust would not disclose the content as this may jeopardise the identity of the whistle-blowers.

Arrangements are put into place to protect the identity of persons raising concerns to ensure staff can raise concerns without fear of reprisals.
