The Trust is contracted with Summit Healthcare (Dudley) Limited to provide the FM services in partnership with its FM Service Provider. The Trust's contract with its PFI Partner started on 17th May 2001 and expires after 17th May 2041

Costs are paid by our PFI Partner as part of a comprehensive Facilities Management Service. The full range of services are paid for by means of a single Unitary Payment and Tariff Adjuster Mechanism which does not identify specific costs.
