The Trust takes violence against staff very seriously and has a zero tolerance policy. Over the past few years we have increased awareness amongst staff regarding the importance of reporting such incidents.

The information above contains both verbal and physical incidents reported against staff but it cannot be determined whether the perpetrators had a mental illness or severe learning difficulties.
