

This is a data request both under the Freedom of Information Act and the Environmental Information Regulations.

In consideration of the climate crisis, I would like to request the following information about how the organisation is enabling staff to reduce their emissions through sustainable transport, and more specifically, cycling.

- 1) over the past five years, broken down by year
  - a. how many staff members used the Cycle to Work scheme?
    - i. 82 employees
  - b. what percentage of staff was this?
    - i. Based on 5599 Permanent staff eligible this is a percentage uptake of 1.5%
  - what was the average value of the vouchers claimed on the scheme?
    i. £1165.81
  - d. what was the number of those who took up the scheme, who then failed to complete, leaving the organisation with costs?
    - i. none
- 2) what tools does the organisation use to encourage cycling for their staff
  - a. on a work basis
    - i. Cycle2Work Scheme
    - ii. Secure bike store and changing facilities with free towels at RHH
  - b. on a leisure/health basis
    - i. working with Dudley Council to:
      - **a.** promote cycling training for child, adults, and families.
      - **b.** Group bike rides
      - c. Maintenance sessions
    - **ii.** General communications to staff relating to the benefits of cycling and promoting 'Let's Ride' and other local cycling events
