## Request

Please can you provide me with the Information below?

- 1.(a) Who is the head of procurement responsible for approving off framework Nursing agency usage? (b) Secondly, who is the temporary / flexible staffing lead responsible for the management of this service?
- 2. Please can you provide the contact number and email address in relation to both question 1 (a) and (b)
- 3. Have you used Off-framework nursing agency staff in the last 6 months?
- 4. How much was your Off-Framework agency spend for each of the following staff groups between 31st January 2023 31st July 2023 (a) RGN's (b) Registered Midwives (c) RMN's (d) ITU Nurses (e) A&E Nurses (f) Community psychiatric nurses
- 5. Following the same breakdown of staff groups in Question 4, how many Off-framework shifts have been unfilled between 31st January 2023 31st July 2023

## Response

We refer to your recent request for information requesting details of agency staff spend. We can confirm we have received a significant number of requests on the same subject matter and we therefore ask in the first instance, you check out our disclosure log of previous FOI requests for the information you have requested. The Trust therefore considers the information you have requested is reasonably accessible by other means as per section 21 of the Freedom of Information Act. This is due to a new database and numbering system being deployed.

The Trust has almost eliminated agency usage and only uses agencies in extenuating circumstances and where authorised in order to support our financial plans and our patient experience. We have recruited significant numbers of additional staff and are making progress with reducing nursing vacancies.
