Thank you for requesting information under the Freedom of Information Act 2000.

#### Request

I am writing to request the following information from your NHS trust:

Performance data against the following two metrics, for the financial years 2019-20, 2020-21, 2021-22, and 2022-23:

- Proportion of service users presenting as emergency admissions who undergo sepsis screening and who, where screening is positive, receive IV antibiotic treatment within one hour of diagnosis.
- Proportion of service user in patients who undergo sepsis screening and who, where screening is positive, receive IV antibiotic treatment within one hour of diagnosis.

Please provide the performance data by 1) proportion of service users presenting as emergency admissions who undergo sepsis screening, 2) the proportion of those patients who, where screening is positive receive IV antibiotic treatment within one hour of diagnosis, 3) the proportion of service user inpatients who undergo sepsis screening and 4) the proportion of those patients who, where screening is positive receive IV antibiotic treatment within one hour of diagnosis.

Please also break down the data by month, and please provide it in excel or CSV format.

We do not have this data recorded monthly only quarterly as this is how it is submitted to NHSE. Screening percentage has not been reported since the end of the CQUIN (national reporting criteria has been quarterly since the CQUIN in 2016)





Figure 1: Quarterly sepsis submission for inpatients from DGFT to NHSE 01/04/16 - 30/06/23
