Request

Please could you provide information from the past 3 months relating to how many patients that been treated for Colorectal Cancer (CRC) with the regimens listed, if possible, please also provide the split of metastatic vs non-metastatic patients for each regimen.

Response

As per NHS Digital rules the Trust does not publish numbers lower than 5 as this could lead to the identification of the persons involved and cause distress to Families or Friends. The number of patients treated for Colorectal Cancer with the regimens listed within the past 3 months requested is less than 5, so Exemption Section 40(2) of the Freedom of Information Act is applied.
