Thank you for requesting information under the Freedom of Information Act 2000.

Request

Response

1. How many patients within the latest annual reporting period were receiving home dialysis treatment (this may be referred to as home haemodialysis or peritoneal)?

As of 09/09/23 we have 13 patients on home haemodialysis and 37 patients on PD.

2a. How many patients within the latest annual reporting period applied for the reimbursement of utility costs for home dialysis treatment?

All 13 patients on HHD were automatically registered for reimbursement and received this. A process is currently being established to reimburse PD patients.

2b. Of these, how many patients were successful?

3. What is the total amount spent by the Trust on the reimbursement of utility costs for home dialysis treatment within the latest annual reporting period?

The Trust has paid from April 24-Aug 24 £1051 on electricity. In 23/24 the Trust paid £5466 on electricity.

The Trust does not have any have any formal guidelines, as a Trust we have always reimbursed patients on home haemodialysis for their electricity.
