Thank you for requesting information under the Freedom of Information Act 2000.

Request

Please could I get the following?

- 1. The trust's 2023-24 CIP performance, broken down by category and scheme. For schemes where it is unclear how the savings have been delivered (EG 'corporate benchmarking' or 'drugs') please could you provide a short one or two sentence explanation on what how the savings were made (EG possible explanations for the categories above could include corporate services headcount reductions for corporate benchmarking and, for drugs, polypharmacy reviews/switches to cheaper drugs).
- a) Please break each category and scheme down by i) planned saving and ii) performance against the plan, full year.
- b) The trust's 2024-25 CIP plan, broken down by category and scheme. Please provide the same explanations as set out above, providing a short description of how each scheme / category is planning to make savings.
- c) Please breakdown the categories by their risk rating, and the % identified and not identified
- 3. The trust's 24-25 CIP performance to date, broken down by plan and actual performance YTD, as well category and scheme. Please could you provide the same explanations as specified in 1.
- 4. A copy of any planned efficiency schemes for 2025-26, including RAG ratings for each proposed schemes. I accept these will not be final but please provide the most recent information.
