- Incorrect. The Dudley Group NHS Foundation Trust formulary requests are peer assessed at the local Drugs & Therapeutics Group, decisions shared with BC Provider Collaborative Acute Trusts and then taken to Black Country Joint Formulary Group (JFG) for agreement and change to joint formulary RAG status. Oversight is by BC IMOG.

3) Does the organisation have representation on the committees listed in question 2? - Yes

4) Are any of the above formularies listed in question 1 dominant when making prescribing decisions or does this depend on therapy area? Please say which is the dominant formulary of the organisation.

- Black Country Joint Formulary is dominant formulary however BNF chapter review (harmonisation) is undergoing and remains dominant until each BNF chapter is agreed at JFG. Entire BNF harmonisation is scheduled to complete 2025/26 where Dudley Formulary will be archived.
