Thank you for requesting information under the Freedom of Information Act 2000.

Request

Firstly, I would like to ask for statistic for the following years 2012, 2013, 2014, 2015, 2020, 2024

The statistics I want to request are :

1. How many samples did your laboratories process in the year. (please provide total of all samples across your all laboratories)

2. How many samples were not able to be processed(again please provide total of all samples across your all laboratories)

3. How many samples needed to resent to Labourites due to being lost or not arriving to the Lab? (again, please provide total of all samples across your all laboratories).

4. How many samples were not able to be processed once they arrived at the lab due to missing data or incorrect data ? (Again, please provide total of all samples across your all laboratories) 5. How many samples arrived to the lab damaged and unusable? (Again, please provide total of all samples across your all laboratories)

6.Please tell me what the main reason is for samples taken not arriving at the lab and needing to be resent.

7. Please can you tell me what the process is of a sample being taken and it arriving to the lab (for instance is there a collection point on the wards where samples are placed to be collected periodically throughout the day ?)

8. When a sample is taken is there a record of the sample being taken or is that samples are only recorded once they are received in the lab (for instance when a swab is taken is there a record of the sample being taken before it arrives in the lab?)
