- The data held in Pharmacy is not based on indication, therefore we cannot answer questions about treatments for specific conditions. In the 6-months Dec24-May25, a total of 167 patients were issued Rituximab, for any condition.

Question Three:

How many patients within your trust have a diagnosis of MS (Multiple Sclerosis)?

- Between 01/10/2024 - 31/03/2025 there were 145 admitted patients coded to the ICD-10 clinical code for MS (G35X). We cannot confirm if this was diagnosed at this visit and we don't keep a list of active conditions for patients

Question Four:
