Please note: The Trust does not electronically record whether a patient undergoes sedation in addition to any local anaesthetic, therefore we are unable to provide figures on the use of sedation as a supplement or alternative to other methods of anaesthesia.

The GA and LA columns provided in the template contain Inpatient episode figures. The total episodes, which we have added as the final column of the information return, includes Outpatient attendances too. Anaesthetic details are not recorded electronically for Outpatient attendances, though the presumption would be that these procedures would not be performed under GA.
