Dear FOI Officer,

I am writing to request information under the Freedom of Information Act 2000. My request is regarding the prevalence and cost of treatment for those who have a dual diagnosis of Type 1 Diabetes and an Eating Disorder within your Trust.

To outline my query as clearly as possible, I am requesting the following information:

2.	Within your Trust how many patients have you treated with Type 1 Diabetes in the year 2016/17? In the year 2016/17 how many patients with Type 1 Diabetes have you treated that are also diagnosed with the following: (Please state whether patients were treated as an inpatient, outpatient or non-elective).	Outpatient attendances are not routinely coded so I cannot say why a patient attended, therefore I can only answer for admissions. During 2016/17 there were 233 admissions where the Primary diagnosis was ICD10 E10* Can only answer for admissions
	a) Anorexia Nervosa?b) Bulimia Nervosa?	There were 0 admissions with a primary diagnosis of Type 1 Diabetes that had a secondary diagnosis of ICD10 F50.0 There were 0 admissions with a primary diagnosis of Type 1 Diabetes that had a secondary diagnosis of ICD10 F50.2
	c) Binge Eating Disorder?	There is no ICD10 code for this
	d) Eating Disorder Not Otherwise Specified (EDNOS)/Other Specified Feeding or Eating Disorder (OSFED)?	There were 0 admissions with a primary diagnosis of Type 1 Diabetes that had a secondary diagnosis of ICD10 F50.8 or F50.9
3.	What is the total number of patients treated within your Trust in the year 2016/17 with a dual diagnosis of Type 1 Diabetes and any variant of Eating Disorders?	There were 0 admissions with a primary diagnosis of Type 1 Diabetes and a secondary diagnosis of Eating Disorder

No. We have joint patients and have open lines of communications with our psychiatric team although not formal MDT

7.	Have you an agreed tariff in the years 2016/17 and 2017/18 with commissioners for this care, if so what is it and what does this care include?	There is no tertiary care tariff for patients with dual pathology of eating disorder and diabetes.
8.	What is the average cost of the treatment for an individual with a dual diagnosis of Type 1 Diabetes and any variant of Eating Disorders in the year 2016/17?	The tariffs will be based on coding for the 2 conditions for inpatient stays. We do not code for diagnoses for outpatient contacts. This is as per PbR
9.	Do you have the ability to fund prolonged stays in private hospitals for the patients that are most in-need of treatment?	We do not commission or provide specialist mental health related beds or care
