Request Under Freedom of Information Act 2000

Thank you for requesting information under the Freedom of Information Act 2000.

- **1. Total Spend and Volumes:** The total spend (in £) and volume (number of procedures) for both in-house and outsourced provisions for each of the following ophthalmology procedure groups: Cataract surgeries, AMD – eye injections, AMD - photodynamic therapy, LASIK, SMILE, Corrective laser eye surgeries (e.g. PRK, LASEK, TransPRK)

If your records use different categorisations or sub-categories within these procedure groups, please provide the total spend and volumes for those as well.

This is for in-house activity only. Our figures use PbR National Tariff, which is a proxy for costs incurred (total spend)

OPCS4 codes used to identify the procedures at patient level were provided by the Clinical Coding department and are as follows:

- Cataract Surgeries - C751 plus C711 or C712 or C718 or C719
- AMD - eye injections - C794. The presence of an ICD10 diagnosis code of H353 is required to definitively allocate this procedure as 'for AMD'
- AMD - photodynamic therapy - C882. The presence of an ICD10 diagnosis code of H353 is required to definitively allocate this procedure as 'for AMD'
- LASIK - C442
- SMILE - C451 plus Y085
- Corrective laser eye surgeries:
 - LASEK - C445
 - PRK - C444
 - TransPRK - C444

Note re Procedures for AMD - eye injections & photodynamic therapy.

These are carried out both as day cases and outpatients.

To state that an eye injection is carried out for AMD we must have a positive diagnosis of AMD.

Whilst Clinical Coding for diagnoses is mandatory for daycases, it is not for outpatients.

As far as possible, we have identified at patient level whether or not there is a diagnosis of AMD.
