What's the longest time someone has been continuously signed off work at your Hospital Trust, because of anxiety/stress/depression or other psychiatric illnesses?

As this question is referring to an individual person's sickness record, a Trust response could inadvertantly identify that person and could potentially cause them harm or distress particularly if the response is to be published in the public domain via the Press. There is a possibility that not only they, but also their relatives or friends would be able to make the association of the published information with the Trust individual. The collection of sickness information from a Trust member of staff would have been for a specific purpose and the member of staff would not have the expectation that this information would have been published outside of the Trust for any other reason.

- How much do you estimate it has cost you having your employees signed off because of anxiety/stress/depression or other psychiatric illnesses in the past 12 months and every year for the past 5 years? (i.e. costs of covering staff)

Information stating absence and any reasons for covering an absence is not held centrally on an electronically reportable system. To retrieve information for each of the last five years from local systems is estimated would take over 18 hours.
