Dudley Group NHS FT calls various additional worked units of activity under the heading WLI payment. The claim form is titled as “WLI Claim Form” however it includes claims for additional payment for additional work carried out on top of the consultants and non consultants’ job plan. This may not be specifically associated with a reduction in a specialty’s Waiting List.

In the figures below it includes costs associated with On call, Additional Administration, Additional Theatre Sessions, Additional Outpatient Sessions, Radiology and Pathology reporting, and additional ward rounds. It covers claims every day of the week (Including sat and sun) evening sessions and some on-call for nights.

The figures also include non-consultant grades who claim using DGFT WLI Claim forms.
