2012-13 Midwife-led = 1787 Consultant-led = 2929

2013-14 Midwife-led = 1202 Consultant-led = 3278

2014-15 Midwife-led = 873 Consultant-led = 3522

2015-16 Midwife-led = 716 Consultant-led = 3669
