1. What is the composition of the multi-disciplinary team for dermatology in the Trust? Consultant dermatologists, pathologist, junior dermatology medical staff, Clinical nurse specialists.

2. How many dermatology consultants work within the Trust? 5 whole time equivalents

3. How many speciality dermatology nurses work within the Trust (including dermatology clinical nurse specialists and dermatology nurse practitioners)? 2

4. Does the Trust have standards to support healthcare professionals to deliver psychodermatological care? No
