I am writing to you to make a request under the Freedom of Information Act 2000 to request the following information from your Trust regarding Car parking Management:

- 1. Number of Car Parking Spaces across your Trust, broken down by:
- a. General or Staff bays Cannot calculate as some car parks are mixed use i.e. staff, patients and visitors
- b. Patient and Visitor bays Cannot calculate as some car parks are mixed use i.e. staff, patients and visitors
- c. Designated Disabled (blue badge) bays 81
- d. Other (such as drop-off or on-call if not counted elsewhere) 9
- e. Total number of parking spaces 2006

This data is only required at Trust level, please do not break down to site level

	home address is more than one mile away from their place of work.
5	Unpaid volunteers and registered home address is more than one mile away from
	their place of work.
6	Students and trainees who are not on an official payroll or do not receive any
	grants, bursaries etc. and live more than one mile from their place of work.
7	Requirement to catch two or more buses/trains to get from registered home
	address to place of work or takes more than 30 minutes on public transport to get
	from registered home address to place of work.
8	Permanent night workers whose registered home address is more than one mile
	away from their place of work.
9	Permanent weekend workers whose registered home address is more than one
	mile away from their place of work.
10	Permanent evening workers who work between 16:00hrs and midnight whose
	registered home address is more than one mile away from their place of work.
