Thank you for requesting information under the Freedom of Information Act 2000.

Request

For the years 2019, 2020, 2021 and 2022:

- How many post-mortem examinations were performed?

- What was the average number of days between the time of death and the release of the body after a post-mortem examination?

- How many pathologists worked in the trust (in WTE)?

Response

2.What was the average number of days between the time of death and the release of the body after a post-mortem examination?

Unfortunately, this data is not held electronically and would have to be manually collated and would therefore breach the 18-hour time frame as per section 12 of The Freedom of Information Act.

Freedom of Information Act 2000 (legislation.gov.uk)

12Exemption where cost of compliance exceeds appropriate limit.

(1) Section 1(1) does not oblige a public authority to comply with a request for information if the authority estimates that the cost of complying with the request would exceed the appropriate limit.

(2) Subsection (1) does not exempt the public authority from its obligation to comply with paragraph (a) of section 1(1) unless the estimated cost of complying with that paragraph alone would exceed the appropriate limit.

(3) In subsections (1) and (2) "the appropriate limit" means such amount as may be prescribed, and different amounts may be prescribed in relation to different cases.

(4) The **[F1**Minister for the Cabinet Office**]** may by regulations provide that, in such circumstances as may be prescribed, where two or more requests for information are made to a public authority—

(a)by one person, or

(b)by different persons who appear to the public authority to be acting in concert or in pursuance of a campaign,

the estimated cost of complying with any of the requests is to be taken to be the estimated total cost of complying with all of them.

(5) The **[F2**Minister for the Cabinet Office] may by regulations make provision for the purposes of this section as to the costs to be estimated and as to the manner in which they are to be estimated.

3. How many pathologists worked in the trust (in WTE)?

We have 1 pathologist who works part time at RHH directly for the coroner, since the Histopathology lab have moved over to New Cross, we don't have any pathologists on site working directly for RHH.
