Thank you for requesting information under the Freedom of Information Act 2000.

Request

Can you please provide me with the below information?

- 1.(a) Who is the head of procurement at The Dudley Group NHSFT responsible for approving Nursing agency usage?
- (b) Secondly, who is the temporary / flexible staffing lead responsible for the management of this service at The Dudley Group NHSFT?
2. Please can you provide the contact number and email address in relation to both question 1 (a) and (b)
3. Have you used Off-framework nursing agency staff in the last 2 months at The Dudley Group NHSFT?
4. How much was your Off-Framework agency spend for each of the following staff groups between January 2022 – April 2022 (a) RGN's (b) Chemotherapy Nurses (c) RMN (d) Specialist RN (ITU) (e) Specialist RN (A&E) (f) Community Psychiatric nurse
5. Following the same breakdown of staff groups in Question 4, how many Off-framework shifts have been unfilled between April 2023 – July 2023?

Response

We refer to your recent request for information under the Freedom of Information Act 2000 requesting details of any expenditure the Trust may have incurred as result of any agency staff spend. We can confirm we have received a significant number of requests on the same subject matter and we therefore ask in the first instance, you check out our disclosure log of previous FOI requests for the information you have requested. The Trust therefore considers the information you have requested is reasonably accessible by other means as per section 21 of the Freedom of Information Act. If, after looking at previous responses you feel these do not answer your request, could you please refine your request and advise what other information you require which you have not been able to locate.

Please note, when searching for a response by word on the disclosure log all FOI requests that were logged from 1/4/23 will show on the first page onwards and any FOI requests that were logged up until 31/3/23 will be shown on the last pages of the disclosure log. This is due to a new database and numbering system being deployed.

The Trust has almost eliminated agency usage and only uses agencies in extenuating circumstances and where authorised to do so in order to support our financial plans and our patient experience. We have recruited significant numbers of additional staff and are making progress with reducing nursing vacancies.

If you are dissatisfied with our response, you have the right to appeal in line with guidance from the Information Commissioner. In the first instance you may contact the Information Governance Manager of the Trust.
