What solution(s) do you use to manage / improve data quality and what is the scope, e.g., is clinical data included?

Locally developed SSRS and PowerBi reports and nationally available Data Quality Maturity reports via NHS England Portal are used to monitor Data Quality. The scope varies dependant on the subject. We also have a Data Quality Kitemark policy that's applicable to any data subject to assess the quality of a given data item. There is also a Data Quality and Standard's group that has a reporting route to exec level for items of organisational concern.

How do you manage care planning (e.g., ReSPECT) across multiple providers and teams, e.g., acute, mental health, social care?	The Trust has multiple systems that allow across agency collaboration, most are bespoke designs to meet business and care needs.
What are your plans around creating your system level data/integration strategy?	The Trust is constantly engaged with our collaborative partners and are still in the early stages of data and system alignment. We have procured a Master Data Manager solution to allow easier integration of disparate provider data as use cases become viable while a single integration strategy is implements
