1. I would like to see all emails, documents, attachments, and any other forms of response relating to this request between the trust and the two senior NHS officials.

- A search of the Chief Executives and the Chief Operating Officer emails has been done and we cannot find anything from the names listed.

2. It is public information that you have been asked to inform the NHS when you "envisage adopting already available nationally commissioned local Products".

It is required to be public information, however our programme of work is being coordinated by our Integrated Care Board colleagues, and as yet we have no commencement date for the adoption of these products as we await the programme plan.

3. I would like to know when specifically, you plan to start adopting the FDP – As per question 2

and who you are naming as lead (as is requested in the letter)? - the digital and BI leads will be Ravi Sahota-Thandi Operational Chief Information Officer, Chris Benfield Head of Analytics and Insight and the operational lead Karen Kelly Deputy Chief Executive.

4. I would also like to know what your plans are for how you will maximise the benefits of the Federated Data Platform to deliver better joined-up care for their patients within the next two years (again, asked of you in the above mentioned letter)?

- Until our programme of work has been detailed we would be unable to respond to this question fully.
