Please can you provide the following information under the Freedom of Information Act 2000 for the period 1 January 2020 to 31 October 2025 (or for as much of this period as your records allow). Please note, I want total figures not an annual breakdown, please.

1. Please tell me how many people were admitted to hospitals in your trust where a primary diagnosis of ICD-10 codes J45–J46 (asthma) was recorded.

For clarity, this includes: J45 – Asthma, J45.0 – Predominantly allergic asthma, J45.1 – Non-allergic asthma, J45.8 – Mixed asthma, J45.9 – Asthma, unspecified, J46 – Status asthmaticus (severe, life-threatening asthma attack unresponsive to standard treatment)
