Q1. Please provide the total number of patients treated in the last 6 months for:

- Polycythaemia Vera (ICD10 code D45) - 1
- Myelofibrosis (ICD10 code D47.4) - 8
- Myelofibrosis (ICD10 code D47.4) patients aged 65 and older - 8
